If hard copy is allowed then a complete set of Bidding Documents may be purchased from the office Uttargaya Rural Municipality, Rasuwa Uttargaya-05 Rasuwa Laharepauwa and the office Uttargaya Rural Municipality, Rasuwa Uttargaya-05 Rasuwa Laharepauwa by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of NRs.1000.0 till 25-05-2026 12:00 during office hours.

6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 25-05-2026 12:30 at the office of Uttargaya Rural Municipality, Rasuwa Uttargaya-05 Laharepauwa, Rasuwa Bagmati Province Nepal.
Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of 37500 , which shall be valid for 30 days beyond the validity period of the bid (i.e. [Refer Clause ITB 20.1]).
